The moratorium prohibiting, *inter alia*, all types of suits, recovery, or other actions against **Sevenhills Healthcare Private Limited** under Section 14 of the Insolvency and Bankruptcy Code, 2016 is ordered with effect from March 13, 2018 till (i) completion of the insolvency resolution process; (ii) the National Company Law Tribunal approves a resolution plan under subsection (1) of Section 31 of the Insolvency and Bankruptcy Code, 2016; or (iii) National Company Law Tribunal passes an order of liquidation under Section 33 of the Insolvency and Bankruptcy Code, 2016, whichever is earlier.

The submission of proof of claims is to be made in accordance with Chapter IV of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations 2016. The proof of claim is to be submitted by way of the following specified forms along with affidavit and documentary proof in support of claim:

- Form C - Proof of claim by financial creditors
- Form D - Proof of claim by a workman or an employee
- Form E - Proof of claim submitted by authorised representative of workmen and employees
- Form F - Proof of claim by creditors (other than financial creditors and operational creditors)
